Dear Mr. Monaghan,

This letter is being faxed to you at your request per our meeting with you last Friday.

We will describe to you in a brief synopsis exactly what has been done to Evelyn S. Berwick, M.D. since August 2002 and up to this present day.

It is our wish that you will help Dr. Berwick out of a situation that is literally killing her and destroying her previously spotless medical career.

Thomas R. Hobbs, PhD, M.D. FASAM and Ken Jones Esquire who work at the Physicians Health Program (PHP) appear to be heavily involved in a case of extreme incompetence, collusion, corruption and corporate cover-ups with regard to what they have done to the medical practice of Evelyn S. Berwick, M.D.

These individuals were well aware of the fact that Dr. Solano (UPMC Montifiore) mistakenly referred Dr. Berwick to the PHP as an implied morphine addict.

However, when they learned that Dr. Berwick was injected with morphine in Dr. Solano's emergency department, they did NOTHING to correct their mistake.

As a result of this professional atrocity, Dr. Berwick was terminated from her 26year staff and clinical privileges at Allegheny General Hospital, and Suburban General Hospital and has been placed on the National Practitioners Database with an adverse recommendation. This is a career-ending step that is now causing ruin to Dr. Berwick's career. She has been dropped from participation in several of her large insurance providers' programs and has gone from an \$800,000.00 per year income to the brink of bankruptcy.

As a result of the php referral letters from Mr. Ken Jones and Dr. Hobbs, Dr. Berwick has been dropped immediately from Gateway health plan, keystone health plan west. She has lost employees, thousands and thousands of patients and a great deal of her personal cardiac health.

Dr. Berwick has been reduced to utilizing \$130,000.00 of personal savings, and \$180,000.00 (at eight percent interest) of her family's insurance policy's cash value and death benefits in order to pay her office overhead expenses and continue serving her patients as she so cares for their well being.

When Allegheny General Hospital terminated her, Dr. Berwick immediately suffered a near fatal heart attack and she has experienced trauma beyond description from the lies and fabrications they utilized to steal thousands of her patients by terminating her admitting privileges.

When Dr. Berwick's General Business Manager, Robert P. Hussey contacted Dr. Hobbs personally, Dr. Hobbs explained that the PHP sends out letters to all of the hospitals and insurance affiliates of the Doctors who are referred to the Physicians Health Programs drug and alcohol abuse roster.

When Mr. Hussey sent a certified letter to Mr. Ken Jones Esquire, requesting answers to why they did not rescind their correspondences or even send us copies of what letters they sent and to whom, Mr. Jones never responded to this quite formal request.

As a result, Mr. Hussey called Mr. Jones at the PHP several times but Mr. Jones refused to come to the telephone or return any frantic calls to discuss this catastrophe he and Dr. Hobbs created!

In a tragic and final irony to the abuses that UPMC has heaped upon Dr. Berwick, she is being barred from admitting patients to UPMC Passavant and South Side Hospitals because the Medical Staff Office will not approve her application due to her attempt to sue UPMC for Defamation of character, even though the Credentials Verification Office passed her.

Luanne Brindle of the Medical Staff Office explained to Mr. Hussey that she was told to "Keep Dr. Berwick out of Passavant U.P.M.C."

Throughout this entire ordeal Dr. Berwick was unable to obtain any legal representation because she could not afford to defend herself against these gigantic and corrupt organizations.

At this time, Evelyn S. Berwick, M.D. is sending out a last ditch effort plea to the Department of State of the Commonwealth of Pennsylvania Bureau of Enforcement and Investigation to launch an extensive and thorough examination of the unconscionable behavior of:

This is a complex and unusual case because so many corporate cover-ups are involved and so many individuals refuse to speak with us so as not to implicate themselves in what are apparently serious felonies committed against a totally innocent and humble Board Certified Internal Medicine Specialist in Family practice.

Evelyn S. Berwick, M.D. deserves to be “righted” and at this point only the State of Pennsylvania can properly help her.
