Thank you for arranging our meeting with you and your wife, Dr. Berwick.





NOT VERY well

We have confirmed as best we can that the PHP has no evidence, to include any documentation, which would support any postulation or theory that Dr. Solano had referred Dr. Berwick to the PHP at any time based on any suspected use or abuse of any narcotic or any other controlled substance.

Absent such evidence, or any other direct evidence from a third party that Dr. Solano had ever communicated any drug abuse problem relative to Dr. Berwick, this entire matter would appear to have no substance. As a result, your demands for payment [20 mil., 10 mil., 5 mil., etc.] are inappropriate.

My suggestion is that you proceed to consult with an experienced personal injury lawyer, and thereafter, if this lawyer is of the opinion that this matter should be pursued, we will be happy to sit down with your lawyer to discuss this matter further.

Finally, incidental to any such consultation, if you or your lawyer would like us to further extend the time for your filing of any lawsuit in this matter we will be pleased to consider such a request.
